**REGARDING THE CHANGE OF PROGRAM ADMINISTRATOR AND DATA CONTROLLER**

Dear Sir/Madam,

We are constantly improving the quality, accessibility, and security of our services, and therefore we are seeking the best business management solutions.

We would like to inform you that as of **2026-04-01**, the B1.It accounting software (hereinafter referred to as “B1”) will be managed and administered by **Site.pro Ltd** (hereinafter referred to as the “New Controller”), located in Cyprus, with the registered address Promachon Eleftherias, 1, Floor 1, Flat/Office 18/19 Agios Athanasios, 4103, Limassol. Consequently, the data controller responsible for processing your personal data related to our activities will change.

Currently, the administrator and data controller of the B1 accounting software, as well as your personal data controller, is UAB “B1.It”, company code 304868214, registered and correspondence address Taikos pr. 52C, Klaipėda, LT-91184, email: info@b1.lt, phone: +370 46210322.

From this date, the New Controller will become the administrator and data controller of the B1 accounting software, as well as your personal data controller.

Below is important information to ensure you are fully aware of your rights and the changes:

### **1. What Remains Unchanged**

B1 accounting software services will continue to be provided and personal data processed as usual. All services you have ordered through B1 will continue to be delivered normally; only the administrator and controller of B1 is changing.

The purposes, methods, and legal bases for processing your personal data remain unchanged. Your personal data will continue to be processed in the same manner, scope, and on the same legal bases as set out in the [Privacy Policy](#).

Your rights under the General Data Protection Regulation (**GDPR**) — including the right to access, correct, delete, restrict processing, object to processing, data portability, etc.— remain fully valid. The purposes of personal data processing do not change, and your personal data will continue to be processed as described in the [Privacy Policy](#) and [Terms](#).

The New Controller undertakes to comply with all obligations under the GDPR and other applicable data protection laws to the same extent.

Your data will continue to be stored in the servers described in the [Privacy Policy](#).

## 2. What This Change Means for You in Practice

B1 accounting services will continue to be provided to you in the same manner. Only the administrator (controller) of the B1 accounting software is changing, and the New Controller will assume this role.

UAB “B1.It” will continue to process your personal data as a data processor.

Any requests you submit (e.g., access to data, corrections, deletions, or other rights) and other questions regarding the use of B1 will continue to be handled according to the [Terms](#) and [Privacy Policy](#). For exercising your rights, you may continue to contact the data processor UAB “B1.It” at [info@b1.it](mailto:info@b1.it).

If certain service delivery or personal data processing processes, contracts, or conditions change due to the change of the controller, you will be informed separately and provided with updated conditions or agreements.

## 4. Your Rights and How to Exercise Them

We hope that the change of the B1 administrator and controller will not affect your decision to continue using the B1 accounting software.

If you decide not to continue using B1, you may terminate services according to the procedures specified in the [Terms](#).

Under the GDPR, you have the following rights:

- The right to request access to your personal data
- The right to request correction of inaccurate data
- The right to request deletion of data (“right to be forgotten”)
- The right to restrict data processing
- The right to object to certain types of data processing

- The right to data portability
- The right to withdraw consent (where processing is based on consent)
- The right to lodge a complaint with a supervisory authority (e.g., the Lithuanian State Data Protection Inspectorate)
